**Extract from DSISO Rules**

**GN 8 Records**

**GN 8.1** Short and Long Course World and Regional Records may be established for each event (as applicable). World and Regional Records will be maintained separately for DS Trisomy 21 and for Mosaic DS. Records may be established for the following Age Groups (age as of 31 December in year of competition establishing Record):

GN 8.1.1 Open - all Registered athletes

GN 8.1.2 Junior – athletes under 17 years of age

GN 8.1.3 Masters; in 2 (two) age bands:

GN 8.1.3.1 Masters 1 - 25 to 34 years of age

GN 8.1.3.2 Masters 2 - 35 years of age and over

**GN 8.2** Records may be submitted from any event held under Fina, IPC, DSISO or a Fina-member national governing body rules.

GN 8.2.1 All Records are to be submitted together with a certificate of pool length (if not already recognised by DSISO<sup>1</sup>)

GN 8.2.2 Records will only be accepted with a primary electronic time from a recognised sports timing manufacturer or by 3 hand held timers.

GN 8.2.3 All Records must be attested by a nationally qualified Referee

GN 8.2.4 Records are first to be submitted to NSOs

GN 8.2.5 Records submitted without the necessary documentation or outside of the time limits will not be considered.

<sup>1</sup> DSISO recognises pools that have previously held DSISO, Fina, IPC or Events recognised by the National Swimming Governing Body in membership of Fina.

The original papers must be sent to the Records Officer (see below) using Recorded/Registered Delivery or other secure delivery within 28 days as currently stipulated.

The sender is urged to keep copies of all papers sent.

The Records Officer will copy the papers and send the copies by regular surface mail to the Records Officer. The Records Officer will notify all, by e-mail, of the receipt and subsequent dispatch of the papers.

The receipt of the papers by the Records Officer will be acknowledged with 7 days by e-mail.

Within 14 days of the receipt of papers by the Records Officer she/he will notify the Member Country by e-mail of the approval or otherwise

If approved, the Records will be published on the DSISO Website within 28 days of the receipt of the papers by the Records Officer.

Where a response within the designated periods is not possible by any DSISO officer due to other commitments this will be published on the Website as appropriate.
